#### Chairman Comments

Carol Watson thanked Ron Holladay for his assistance to the Conservancy the last few weeks.

#### Minutes

David Bisher moved to approve the minutes of May 17, with second of Ron Holladay. Motion carried with 6 Aye (unanimous vote).

### Customer Service Report

There were 14 reports in May, and 10 of the issues/questions are resolved. The distribution of topics includes: 1 water quality (color), 4 irrigation questions, 2 hydrant flushing, 4 water consumption questions; 1 connection question and 2 miscellaneous.

## Water Superintendent Report

Dan Gemmecke recognized Steve Easter and Ron Holladay for covering system duties while he was away. He requested approval to engage Iseler Demolition Company to remove the old water tower at the Tower 2 site. Philip Baer moved to approve the expense, not to exceed \$32,000. Second of Joe Kline. The deconstruction will use a crane to lower the tank and cut the sections while on the ground, Call for the question, motion carried with unanimous vote.

The Tower 2 project still requires a generator at #3 wellhouse. This will be procured on the open Build-Operate-Transfer contract. Philip Baer moved to approve the generator placement, with second of David Bisher. **Motion** carried with unanimous vote. The expenditure was estimated at \$65,000.

An assistant superintendent job description was posted and Kevin Denny was hired. He will be away for a planned vacation, returning full time after July 10.

#### Financial Clerk

Joe Kline moved to approve the register of claims May to June 21. Second of Andrea Agree, motion carried with unanimous vote.

The 2023 salary ordinance was amended for the assistant superintendent position. David Bisher moved to adopt Ordinance 23-18 Amendment to Salary Ordinance 2023 which increases the hourly wage range maximum rate for the assistant superintendent to \$30.00 and allows an additional 11.2% if the employee is not eligible for Indiana Public Employer Plan retirement benefit. Second of Ron Holladay, motion carried with unanimous vote.

#### Old Business

The District Plan process moves forward with a resolution to bring all petitions to the court for approval. Joe Kline moved to approve Resolution 23-38 A Resolution Adding Additional Territory to and Removing Area from the District, and Defining Director's Areas of the Battle Ground Conservancy District. Second of Andrea Agree. The resolution will be used with a new plan document which includes all petitions to join and remove from the district. Call for the question, motion carried with unanimous vote.
