David Bisher called the Annual Meeting of Conservancy District Freeholders to order at 6:00 p.m. with roll call of Directors.

#### **Director Election**

There was one nominee for the open director chair in Historic Battle Ground / River Bluff. In this case, an election is not required. Ron Holladay **moved** to approve Rick Oliver by acclamation to the new term, with second of Carol Watson. Motion carried with unanimous vote of the directors.

# Oath of Office

The Director's Oath for Rick Oliver was administered by Georgia Jones, Clerk-Treasurer of the Town of Battle Ground.

# **Annual Financial Report**

Financial Clerk Georgia Jones provided the Conservancy District 2025 Budget and estimated revenue. The state-approved operating budget total is \$1,032,581 and the estimated revenue is \$1,026,895. The property tax component of the budget remains allocated to capital projects. A copy of the handout information is attached to these minutes.

- > Hydrant Maintenance
- ➤ Had an increase in 811 locates
- District Plan finalized
- Estimates for Booster pumps
- ➤ Leap Project
- ➤ Battery Storage in White County

- ➤ Booster Bldg. upgrade
- Cleaning and rebuilding of one well and pump

- > Remediation for lead /copper to review 10% of system services per year for 10 years.
- > Completion of the larger diameter water main on Main Street

# Water Superintendent Report

Dan Gemmecke advised the board the lease agreement with Tipmont is complete for 2025. There will be credit to offset the monthly expense of three internet connections used by the SCADA system.

The department is ready to post a full time (30 hours) assistant or trainee position.

#### Minutes

# Financial Clerk

Rick Oliver **moved** to approve the registers of claims. There are three documents, the escrow transfer (\$86,377.50), Dec 19-31 (\$73,700.70), and Jan 1-15 (\$7,644.52). Second of Carol Watson, motion carried with unanimous vote.

The financial clerk advised the board of a new utility office schedule for winter, open weekdays from Noon to 4 PM and other times by appointment as needed.

#### **Old Business**

Conservancy District Plan – The court appearance was Monday January 13, and the judge requested additional information which the attorney will provide.

Town Hall - No additional information

Utility bill non-payment and shutoff policy statement is deferred to February. The position description for the billing clerk vacancy has been reviewed by committee and will be discussed with the clerk.

# **New Business**

Director - After the District Plan is fully enacted and adopted, there will be a posting for a director from the area north of CR 600N. The vacancy will be advertised per statute, and nomination forms presented to the clerk on or before February 17, 2025. The nominee will complete the term vacated by Andrea Agree, covering the years 2024 to 2027.

Insurance – Phil Baer commented there will be a document from Brad Chesterman, a broker letter of record, which the Conservancy will sign indicating acceptance that he will represent the district in matters of hazard and liability insurance. Brad met with James Miller to determine if the town of Battle Ground will also have Brad as their broker.
